## **NOTIFICATION**

Islamabad, the 1st October, 2020

No. 9-2/2018-P.O-I (Pt). In exercise of the powers conferred by clause (c) of sub-section (2) of section 6A of the Anti-Money Laundering Act, 2010 (VII of 2010), the Pakistan Post (AML and CFT) Supervisory Board is pleased to make the following guidelines, namely:-

- 1. **Short title, extentand commencement.-** 1) These guidelines shall be called the Pakistan Post (Targeted Financial Sanctions) Guidelines, 2020.
  - 2) These guidelines shall apply to Pakistan Post.
  - 3) These guidelines shall come into force at once.
- 2. **Legal Obligations.-**TFS obligations are provided under the following legal instruments:
  - (a) United Nations (Security Council) Act, 1948 (UNSC Act)
  - (b) United Nations Security Council (Freezing and Seizure) Order, 2019
  - (c) Statutory Regulatory Orders (SROs) issued under UNSC Act
  - (d) Anti-Terrorism Act, 1997 (ATA)
  - (e) Notifications issued under ATA
  - (f) AML Act, 2010
- 3. UNSC and Domestic Sanctions Regimes.- The Government of Pakistan under the UNSC Act gives effect to the decisions of United Nations Security Council (UNSC) whenever the Consolidated List is updated maintained by the relevant Sanctions Committee. The details of sanctions imposed by the UNSC along with the Consolidated Lists are available on the UNSC Sanctions Committees' websites at the following links:

- 4. **UNSC Sanctions.-**1) MOFA issues SROs to provide legal cover for implementing sanction measures under UNSC resolutions. These SROs in respect of designated individuals/ entities require assets freeze, travel ban and arms embargo in addition to other measures in accordance with the UNSC resolutions, and are available publicly at the following links:

- 5. **Dissemination of Changes.-** 1)To ensure prompt transmission of SROs issued by MOFA to relevant stakeholders, including Pakistan Post, MOFA has put in place an email subscription service.   - 2) In addition to above, Supervisory Board also circulates the subject SROs/Notifications to Pakistan Post as an additional measure.
